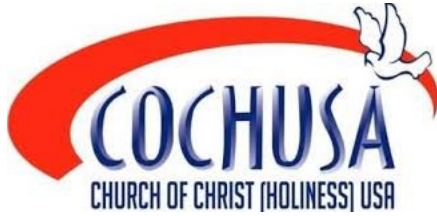

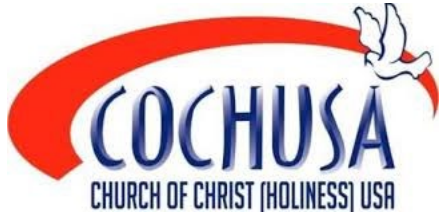
COCHUSA LOCAL CHURCH EVANGELISTIC GRANT

PURPOSE POLICY & PROCEDURES

The purpose of the National Evangelism Fund Local Church Grant is to fund "new" evangelistic initiatives help develop new healthy church initiatives and evaluations, that will ultimately help the growth of the local COCHUSA churches in spreading the life changing gospel of Jesus Christ.

POLICY & PROCEDURES

The grant is administered and managed by the COCHUSA LOCAL CHURCH EVANGELISTIC GRANT COMMITTEE under the oversight of the National Church Evangelism & Mission Board (NCE&MB). The NCE&MB will have a clearance and consulting role to help the Grant Committee to determining a local church standing with other COCHUSA loans and help expedite the funding process for approved applicants. The approval of all grant applications will however be made by the Grant Committee. All applications must be received by the committee during published open application dates. Applications received after the close of the published application period can be considered for the next funding period. They must re-apply and submit a new application with required signatures and understanding that new initiatives take priority.

REQUIREMENTS FOR FUNDING UNDER THE LOCAL CHURCH GRANT

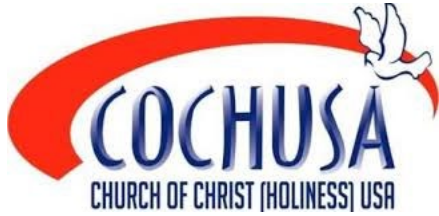
1. Applications must be from a local church.
2. Applicants must complete a new application annually to be considered for the Grant each year. The application form can be found online at www.cochusa.org.
3. The application must include a detailed description of the new evangelistic effort, which must be specific and measurable for accountability purposes.
4. Description should include expected outcome or goal of the project.
5. The application must be typed and have the approval of the local pastor, District Chairman and presiding prelate of the Diocese. Applications must contain physical signatures; electronic signatures may be accepted upon verification.
6. Applications must be accompanied by a budget for the new project.
7. Local churches applying for the COCHUSA LOCAL CHURCH EVANGELISTIC GRANT funds must have paid their National Ministry Fund assessment at 100% in the most recent church fiscal year or be exempt by the Bishop.
8. Applicants who have received the COCHUSA LOCAL CHURCH EVANGELISTIC GRANT are required to complete and submit a "MAKE GOOD REPORT", accountability form to the Grant Committee after the Evangelism event has been completed.
9. Failure to submit the "MAKE GOOD REPORT" will disqualify the local church from applying for future grant consideration.



COCHUSA LOCAL CHURCH EVANGELISTIC GRANT

APPROVAL PROCESS

1. Applications will be reviewed and approved by the Grant Committee on a first come first serve basis.
2. Funding request will be awarded to new initiatives that allow the church to interact with Local community and have a clear measurable vision.
3. Maximum Grant amount for 2022 is \$2,500 per grant application
(Maximum grant amounts may vary annually)
4. Grant Applications and Grant Funding request must be made annually, and past funding is not a guarantee of future funding.
5. All required signatures must be provided by the authorized officer or his/her designee. Electronic may be accepted upon verification. Incomplete applications will not be considered for funding.
6. Funding of the COCHUSA LOCAL CHURCH GRANT will be made within 10 days of application approval and verification of eligibility.
7. Grant checks will be made payable to the local church.
8. All Approved Grant Applications "MUST HAVE"
 - A. Local Pastor Signature
 - B. District Chairman Signature
 - C. Presiding Bishop Signature

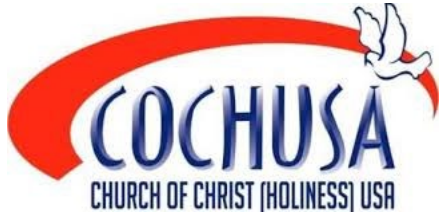
